### Arizona Barbering & Cosmetology Board Meeting October 23, 2023, | 9:00 a.m. Virtual Meeting

#### IV. Review and Discussion of Desired Legislative Updates

The discussion will start with 4.Unlawful Acts under the Regulations section that was continued from the prior meeting. Then, all items tabled from the previous meeting will be discussed.



#### **Regulations**

#### 4. Unlawful Acts

**Board Recommendation: 32-X74** 

Ensure all requirements apply to all licensees and all establishment types. Change language in row 3 to say "Each establishment shall have an individual designated as the manager of the establishment."

**Motion:** Cathy Koluch makes a motion to accept the board staff recommendation 32-X74 regarding unlawful acts. **Motion passed unanimously.** 

**Motion:** Cathy Koluch makes a motion to accept staff recommendations to add language row 3 to say "Each establishment shall have an individual designated as the manager of the establishment" for both the barber and cosmetology section. **Motion passed unanimously.** 

**Motion:** Cathy Koluch makes a motion to accept staff recommendations to add language to row 11 for the cosmetology section to match the barber section. **Motion passed unanimously.** 

**Motion:** Cathy Koluch makes a motion to accept staff recommendations to add language to the barber section on row 13 to match the cosmetology section. **Motion passes unanimously.** 

**Motion:** Cathy Koluch makes a motion to accept staff recommendations to add language to the barber section on row 15 to match the cosmetology section. **Motion passes unanimously.** 

**Motion:** Cathy Koluch makes a motion to accept staff recommendations to add language to the barber section on row 16 to match the cosmetology section. **Motion passes unanimously.**

#### Licensing

4. Instructor Licenses

## (B) Barber Instructor Exam Requirement Board Recommendation: 32-X31

Require both written and practical examinations for all instructor license applicants.

**Motion:** Cathy Koluch makes a motion to accept board staff recommendation 32-X31 on section B to require both written and practical examinations for all instructor license applicants and to add that the applicant must complete the infection



prevention/sanitation class.

Motion passed unanimously.

## (C) Barber Instructor Experience Board Recommendation: 32-X31

Lower the barber instructor requirement to one year of experience.

**Motion:** Cathy Koluch makes a motion to accept board staff recommendation 32-X31 on section C to lower the barber instructor requirement to one year of experience and add the ability to challenge the board.

Motion passes unanimously.

### (D) Barber Instructor Training Hour Requirement

**Board Recommendation: 32-X31** 

Require all Instructor applicants to have completed 350 hours of instructor training.

**Motion:** Cathy Koluch makes a motion to accept board staff recommendation 32-X31 on section D to require all instructor applicants to have completed 350 hours of a board approved instructor training.

Motion passes unanimously.

#### Schools

#### 3. Separation of Schools from Other Businesses

**Board Recommendation: 32-X56** 

Statute to read: A school of any type may include programs related to a subject that the board licenses but may not include an establishment. A school may offer sell related products and articles.

**Motion:** Cathy Koluch makes a motion to accept board staff recommendation 32-X56 regarding separation of schools from other businesses.

Motion passed unanimously.

#### Regulations

### 3. Refusal to Issue License & Disciplinary Action

**Board Recommendation: 32-X72** 

The statutes should be equal and include lines 6 and 7 for all licensees.

\*\* A conviction of a crime or act shall not be a cause of refusal to issue or renew a license or registration unless the crime or act is substantially related to the qualifications, functions, or duties of the license or registration for which the application is made.

**Motion:** Cathy Koluch makes a motion to accept board staff recommendation 32-X72 regarding refusal to issue license & disciplinary action.

Motion passed unanimously.
